15 hearing scheduled to begin on September 25, 2017.


17 **Witness List and Summary of Witness Testimony:**

22 will also present testimony as to his expert opinion regarding the requirements for the  
23 design and implementation of an effective monitoring, management, and mitigation  
24 plan, including adaptive management, the feasibility and effectiveness of the  
25 Southern Nevada Water Authority's proposed approach to monitoring, management,

1 and mitigation for its proposed Groundwater Development Project. *See CV at*

- 3 2. Tom Baker, Craig Baker, and/or Dave Baker. One or more of the Bakers will present  
4 testimony regarding current conditions and any changes in conditions since 2011 of  
5 springs and groundwater resources in the region of Snake Valley most likely to be  
6 directly affected by the Southern Nevada Water Authority's proposed groundwater  
7 pumping in Spring Valley. One or more of the Bakers will testify about the harmful  
8 effects that SNWA's proposed Spring Valley pumping would have on their water  
9 rights and groundwater dependent resources in Snake Valley, and on the public  
10 interest.
